7.3.1.1	Capital Outturn 2011/12
	The report of the Economic Portfolio Holder summarised expenditure on the Capital Programme in 2011/12 and explained the reasons for variances from the revised estimate, including a summary of the total budget slippage within the Capital Programme.

The report made recommendations for the carry forward of certain unspent capital budgets into 2012/13 as detailed throughout the report and provided an updated capital programme for 2011/12 to 2013/14.

One new project was recommended to be added to the Capital Programme which related to a replacement system for Committee Agendas and Minutes.

The Economic Portfolio Holder pointed out that new projects financed by the Social Housing Capital Budget was delegated to the Head of Housing and Environmental Health Services in consultation with the Affordable Housing Grants Panel and not the Grants Panel as mentioned in paragraph 4.8 of the report.

Recommended:

- 1. That the updated Capital Programme as shown in Annex 1 to the report be approved.
- 2. That the replacement system for Committee Minutes and Agendas be added to the Capital Programme.

7.3.1.2 <u>Title of Honorary Aldermen/Alderwomen</u>

Council agreed to implement a scheme to award the title of Honorary Alderman of the Borough to past Councillors.

The report of the Leader proposed the details of the Scheme. The Leader also pointed out that the badge on page 58 of the agenda which was intended for recipients who had been Mayor in the past, should have the words "Past Mayor" inscribed at the top of the badge.

Recommended:

- 1. That a Scheme to award the title of Honorary Alderman/Alderwoman of the Borough to past Councillors who have rendered eminent services to the Borough and community, as set out in paragraph 4.1 of the report, be agreed.
- 2. That the Scheme applies to past Councillors with effect from 18 April 2011 when the motion was agreed by Council.
