## **Annex 1 - Mandatory conditions**

### **Section 19 - Mandatory Conditions: Where licence authorises supply of alcohol**

- (1) Where a premises licence authorises the supply of alcohol, the licence must include the following conditions.
- (2) The first condition is that no supply of alcohol may be made under the premises licence:
  - (a) At a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (3) The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

### **Embedded restrictions pertaining to the converted licence if any appear below**

#### **E – Live Music**

1. Provision of live music generally run in conjunction with wedding receptions or parties shall only take place indoors between 2000 and 0030 hours Monday to Saturday.

Reason: In the interest of the amenities of the local residents.

#### **F – Recorded music**

2. Provision of recorded music run in conjunction with wedding receptions and parties shall only take place indoors between 1100 and 0030 hours Monday to Saturday.

Reason: In the interest of the amenities of the local residents.

#### **J – Provision of Facilities for dancing**

Provisions of facilities for dancing to accompany musical performance shall only take place indoors between 1100 and 0030 hours Monday to Saturday.

Reason: In the interest of the amenities of the local residents.

4. The events governed by conditions 1, 2 and 3 above shall be limited to 50 in any one calendar year, 10 of which could be for live music events, the date of the first year to commence on the date this licence takes effect.

Reason: In the interest of the amenities of the local residents.

**Q (d) the prevention of Public Nuisance**

5. During events involving live or amplified music and speech, (other than low level background music), all windows on the façade of the function room facing East and doors shall be kept closed. External doors will also be kept closed except where necessary for access and egress.

Reason: To minimise noise break out from the premises affecting local residents and to avoid the occurrence of public nuisance.

6. Loud speakers associated with the provision of Regulated entertainment involving Live or Recorded music shall not be positioned outside, or otherwise be used to direct music to any outdoor areas, at any time.

Reason: To avoid public nuisance from amplified music/voice at the properties of local residents.

7. The disposal of empty bottles into outdoor storage receptacles will not take place between 1900 and 0800 hours.

Reason: In the interest of the amenities of the local residents.

8. At each exit point a prominent and clear notice will be displayed to the effect that customers should be considerate to local residents by leaving the premises and the area quietly.

Reason: In the interest of the amenities of the local residents.

9. Any amplified music and amplified speech emanating from the premises shall be of a level whilst audible, is so low in volume that distinct lyrics, tunes and musical instruments cannot be recognised at the façade of the nearest residential property Monday to Saturday between 1100 and 0030 hours.

Reason: In the interest of the amenities of the local residents.

10. The licensee or nominated representative shall receive and respond to complaints throughout the duration of all regulated entertainment.

Reason: In the interest of the amenities of the local residents.

1. An audible alarm shall be fitted to all external fire doors which alert staff when they are opened without authorisation.

Reason: In the interest of the amenities of the local residents.

Other Comments:

**Advice to Applicant**

As the premises function room intended for regular entertainment is small and given the frequency and hours of entertainment proposed, extreme care should be taken to ensure that music noise is kept to a minimum so as not to disturb neighbours.

In addition to the conditions the licensee has agreed to subjectively monitor music noise levels, at the boundary of the premises during all events to ensure that the bass beat will be kept to a minimum.
