Club @ Life, London Street, Andover.

Tasking

I have been asked to provide a breakdown of all criminal offences relating to assault, disorder and other incidents of public nuisance relating to the Club @ Life over the previous 12 month period.

The purpose of the analysis is to assist Police in seeking conditions to a Premises License in order to assist in a substantial reduction in the number of criminal offences linked directly or indirectly to the Club @ Life.

Background

On the 13/14th December 2006 there was a serious public disorder incident at the Club @ Life, which resulted in it being closed for a 24 hour period. The premises then reopened with the exception of the nightclub section of the premises. The nightclub was re-opened on 21st December, 2006 with the following conditions:

- No admission or re-admission after midnight
- No service personnel to be granted entry

Methodology

All information in this report has been extracted from RMS and the search dates were 01/12/2005 to 27/12/2006. The search was conducted by entering 6TA01 in the beat field on RMS and pulling back all occurrences. This data was then filtered and occurrences linked to the Club @ Life, London Street, Andover, SP10 2PA were analysed. Note: The Club @ Life has the following variations on RMS, Club at Life, Pub/Club @ Life, Pub at Life, Pub of Life, Flicks, Chaplin's, and Savoy.

Call Management have provided the following figures in relation to the number of calls received by or were generated by the premises, The Club @ Life, London Street, Andover, SP10 2PA. The search period was between 01/01/2006 to 19/12/2006.

Analysis

The time frame for the analysis was 01/12/2005 - 27/12/06.

Analysis was undertaken on occurrences reported on RMS that have been linked to the Club @ Life; this includes occurrences that may have been linked to the other names on RMS for the Club @ Life.

There were a total of 110 occurrences in the time frame searched; the analysis below shows the results.
