Annex 1 – Mandatory conditions

Section 19 – Mandatory Conditions: Where licence authorises supply of alcohol

(1) Where a premises licence authorises the supply of alcohol, the licence must include the following conditions.

(2) The first condition is that no supply of alcohol may be made under the premises licence:

- (a) At a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

(3) The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Section 21 – Mandatory Condition: Door Supervision

 Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, the licence must include a condition that each such individual must be licensed by the Security Industry Authority.
 But nothing in subsection (1) requires such a condition to be imposed:

- (a) In respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c.12) (premises with licences authorising plays or films), or
- (b) In respect of premises in relation to:

(i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule
(premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
(ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).

- (3) For the purposes of this section:
 - (a) "security activity" means an activity to which paragraph 2 (1)(a) of that Schedule applies, and

(b) paragraph 8(5) of that Schedule (interpretation of references to an occasion)

applies as it applies in relation to paragraph 8 of that Schedule

Wording of Condition

Alcohol shall not be sold or supplied except during permitted hours. In this condition, permitted hours means:

a) On weekdays, other than Christmas Day or New Year's Eve, 10 a.m. to 12 p.m. Monday to Thursday or to 1a.m. Friday and Saturday

b) On Sundays, other than Christmas Day or New Year's Eve, 12 noon to 10.30 p.m.

c) On Christmas Day, 12 noon to 3 p.m. and 7 p.m. to 10.30 pm.

d) On New Year's Eve, except on a Sunday, 11 a.m. to 11 p.m.

e) On New Year's Eve on a Sunday, 12 noon to 10.30 p.m.

f) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).

The above restrictions do not prohibit:

a) During the first twenty minutes after the above hours the consumption of the alcohol on the premises;

b) During the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;

c) During the first twenty minutes after the above hours the consumption of the alcohol on the premises by persons taking meals there if the alcohol was supplied for consumption as ancillary to the meals.

d) Consumption of the alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises;

e) The ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;

f) The sale of alcohol to a trader or club for the purposes of the trade or club;

g) The sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;

h) The taking of alcohol from the premises by a person residing there; or

i) The supply of alcohol for consumption on the premises to any private friends of a persons residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or

j) The supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

No person under fourteen shall be in the bar of the canteen during the permitted hours unless one of the following applies:

1) He is the child of the holder of the premises licence.

2) He resides in the premises, but is not employed there.

3) He is in the bar solely for the purpose of passing to or from some part of the premises which is not a bar and to or from which there is no other convenient means of access or egress.

4) The bar is in premises constructed, fitted and intended to be used bona fide for any purpose of which the holding of the licence is ancillary.

5) a) He is in an area shown on the plan attached to the licence.

- b) Meals and non-alcoholic beverages are available for sale for consumption in that area.
- c) He is in the company of a person aged 18 or over.

d) He is there prior to 9 p.m. or between 9p.m. and 9.30 p.m. where he or the said person is consuming a meal purchased before 9 p.m.

In this condition "bar" includes any place exclusively or mainly used for the consumption of intoxicating liquor. But an area is not a bar when it is usual for it to be, and it is, set apart for the service of table meals and alcohol is only sold or supplied to persons as an ancillary to their table meals.

Annex 2 - Conditions consistent with the Operating Schedule if any appear below

1. Live Music

Live music shall only take place inside between the hours of 1000 and 0000 hours Monday to Thursday and 1000 to 0100 hours Friday – Saturday and till 2230 hours on Sunday with the exception of Easter Weekend when the hours will be Friday – Monday 1000 – 0100 hours.

2. Recorded music

Recorded music events shall take place inside only, between 1000 and 0000 hours Monday to Thursday, 1000 – 0100 hours Friday – Saturday and till 2230 hours on Sundays with the exception of Easter Weekend when the hours will be Friday – Monday 1000 – 0100 hours.

3. Performance of Dance and provision of facilities for dance

Dancing and the provisions for dancing to accompany a musical performance shall only take place indoors between the hours of 1000 and 0000 hours Monday to Thursday, 1000 – 0100 hours Friday – Saturday and till 2230 hours on Sundays with the exception of Easter Weekend when the hours will be Friday – Monday 1000 – 0100 hours

4. Anything of a similar description to the above

Quiz nights, Karaoke etc. shall only take place indoors between the hours of 1000 and 0000 hours Monday to Thursday, 1000 – 0100 hours Friday – Saturday and till 2230 hours on Sundays with the exception of Easter Weekend when the hours will be Friday – Monday 1000 – 0100 hours

The prevention of Public Nuisance

5. During events involving live or amplified music and speech, (other than low level background music), all windows and doors shall be kept closed. External doors will also be kept closed except where necessary for access and egress.

6. Regulated entertainment (other than low level background music) will not take place more frequently than 30 times per year.

7. At each exit point a prominent and clear notice will be displayed to the effect that customers should be considerate to local residents by leaving the premises and the area quietly.

8. No amplified music or amplified speech shall be audible at the boundary of the premises after 2300 hours.
