There were a number of incidents that took place during the evening and there are a number of Police statements that relate to the evening. In summary there was a stand off in the garden in the earlier part of the evening which resulted in one male being asked to leave. He did this by going over the pub wall but returned again to try and start another fight. Later in the evening after closing time a number of people were allowed to remain on the premises, at a 'private party' and they all continued to drink. Police were called by a local resident reporting a fight outside at 03.52 hours but when they attended at 04.10hrs no people were outside and the male who purported to be the landlord told the police that it was a private party only. Police were then called again at

						<p>05.46 hours by a member of the public who stated that there was a fight taking place that 'had been going on all night'</p> <p>A police investigation is being pursued but on police arrival all the persons present, between 15 and 25 people were heavily in drink and one by own admission had drunk two pints and then 10-15 vodkas. The only sober person was the pregnant D.P.S and she describes the scene as 'World War Three' and 'Mayhem' but did not call the police.</p> <p>A 16 year old was found on the floor apparently unconscious and was bleeding, he then came to and was violent and spitting at the officers. His father had to be removed home alleging that his son has been served in the pub.</p> <p>In essence a number of disputes had occurred throughout the evening involving the partner of the D.P.S and the 16yr old, the D.P.S and her partner and other guests squaring up to each other. About £400 worth of damage was caused at the pub and D.J equipment was knocked over and smashed. Officers saw glass smashed all over the floor and vomit. At least 6 officers attended for this incident and a ambulance. At no stage were the Police called by the responsible parties in the premises and nothing was mentioned when the Police attended earlier in the evening, this may have prevented the final outcome.</p>

The landlady, Corinne WHITLOCK, informed APS 3664 MACDONALD that the two males had been involved in a fracas inside the pub as one of the males was believed to be dealing drugs inside the pub. Both males were spoken to away from the pub whilst waiting for back up. Both males were described as heavily in drink. One male was searched. In his right back pocket was found a knife. This was a lock knife with a 3 inch blade. He was arrested by DO COOKE at which point he began to struggle. As the handcuffs were being placed on to the rear, the handcuffs caught DO COOKE's right index finger causing bleeding. This male was

						heavily in drink and unable to be dealt with before DO COOKE went off duty and the custody officer recorded the male as being drunk when he was booked into custody. When the male was booked into custody he stated that he had consumed 4 or 5 pints of beer. He was charged with possessing an offensive weapon.
