Annex 1 - Mandatory conditions

Section 19 - Mandatory Conditions: Where licence authorises supply of alcohol

- (1) Where a premises licence authorises the supply of alcohol, the licence must include the following conditions.
- (2) The first condition is that no supply of alcohol may be made under the premises licence:
 - (a) At a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (3) The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Section 20 - Mandatory Condition: Exhibition of Films

- (1) Where a premises licence authorises the exhibition of films the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
- (2) Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation made by that body.
- (3) Where:
 - (a) The film classification body is not specified in the licence,
 - (b) The relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question.

admission of children must be restricted in accordance with any recommendation made by that licensing authority.

(4) In this section:

"children" means persons aged under 18; and

"film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

Section 21 - Mandatory Condition: Door Supervision

- (1) Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, the licence must include a condition that each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in subsection (1) requires such a condition to be imposed:
 - (a) In respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c.12) (premises with licences authorising plays or films), or
 - (b) In respect of premises in relation to:
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section:
 - (a) "security activity" means an activity to which paragraph 2 (1)(a) of that Schedule applies, and
- (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule

Annex 2 - Conditions consistent with the Operating Schedule if any appear below

- Outdoor events including entertainment within a marquee involving live or recorded music or provisions for making music shall not take place more frequently than 6 times per calendar year and shall only take place Monday to Saturday between 1200 and 2300 hours and on Sundays between 1200 and 2200 hours.
- 2. Indoor regulated entertainment shall not take place more frequently than 30 times per calendar year.
- 3. During events involving live or amplified music and speech, (other than low level background music), all windows and doors shall be kept closed. External doors will also be kept closed except where necessary for access and egress.
- 4. The disposal of empty bottles into outdoor storage receptacles will not take place between 1900 and 0800 hours.
- 5. At each exit point a prominent and clear notice will be displayed to the effect that customers should be considerate to local residents by leaving the premises and the area quietly.
- 6. No amplified music or amplified speech shall be audible at the boundary of the nearest residential property between 2300 0800 hours.
