### **Annex 1 – Mandatory Conditions**

- 1 Section 19 - Mandatory Conditions: Where licence authorises supply of alcohol
- (1) Where a premises licence authorises the supply of alcohol, the licence must include the following conditions.
- (2) The first condition is that no supply of alcohol may be made under the premises licence:
- (a) At a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (3) The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

### **Annex 2 – Conditions consistent with the operating Schedule**

- 1 Live performance of duos or solos either acoustic or amplified shall only take place indoors Monday to Sunday between the hours of 1000 and 2300 hours with the exception of New Years Eve when live music can be played up until 0200 hours on New Years Day.
2. Disco or Karaoke recorded music events shall only take place indoors between 1000 and 2300 hours Monday to Sunday with the exception of New Years Eve when recorded music can be played up until 0200 hours on New Years Day.
3. A Pub Quiz or raffles using amplified speech shall only take place indoors between 1000 and 2300 hours Monday to Sunday.
4. Provisions of facilities for dancing to accompany musical performance shall only take place indoors between 1000 and 2300 hours Monday to Sunday with the exception of New Years Eve when recorded music can be played up until 0200 hours on New Years Day.
5. Loud speakers associated with the provision of Regulated entertainment involving Live or Recorded music shall not be positioned outside, or otherwise be used to direct music to any outdoor areas, at any time.
6. The disposal of empty bottles into outdoor storage receptacles will not take place between 1900 and 0800 hours.
7. At each exit point a prominent and clear notice will be displayed to the effect that customers should be considerate to local residents by leaving the premises and the area quietly.
8. No amplified music shall be audible at the boundary of the premises between 2300-0800 hours.
9. The beer garden shall not be used by customers after the hours of 2300 hours.
