Please state the ground(s) for representation:

Hampshire Constabulary has an objection to the variation of the premises licence at Dominos Pizza, Bridge Street, Andover. The objection is based on the Prevention of Crime and Disorder objective under the Licensing Act 2003.

The applicant is seeking to extend the hours for licensable activities and open from 07:00am to 05:00am every day of the week. Late night refreshment is only a licensable activity when it is carried on between the hours of 23:00pm and 05:00am therefore the granting of a licence between these hours will effectively allow the operator to trade for 24 hours a day, 7 days a week.

Hampshire Constabulary have serious concerns that the applicant has failed to adequately assess the risk to both its staff and customers when operating during the early hours of the morning. Our experience both in Andover and across other parts of the county tells us that take away establishments are a hot spot for crime & disorder, particularly alcohol fuelled violent crime and also significantly delay the dispersal of people from the area.

The operating schedule provided by the applicant has, in our view, failed to take into account any of the risks involved with the night time economy or propose any adequate measures to deal with those risks.

The applicants state they will "actively co-operate with the local police to ensure that we are made aware of particular problems which affect the area" but when we made them aware of potential issues such as drunken violent people who would inevitably visit their store if they opened until the early hours, they failed to put forward any measures to mitigate these risks.

The night time economy in Andover is unusual because whilst it may appear during the day to be a medium sized market town, during the evening and weekends there is a significant influx of Army personnel from garrisons at Tidworth and Bulford. The army presence in these areas is set to increase dramatically over the next few years and the challenges associated with it can only increase.

We consider the proposed extension to the opening hours are disproportionate and will lead to resources being diverted from other duties in order to police the area. This will clearly impact their ability to provide cover for their neighbourhoods at other times.

The concerns we raised are not based on speculation but reflect the reality that police officers face at late night venues both in Andover town and else where across the country.

It is an offence, under section 158 of the Licensing Act 2003 to make a false statement in or in connection with this representation

Police recommendations (including any conditions)

We are not opposed to an increase in hours per se but feel a terminal hour of 00:00am on Sunday to Thursday inclusive and 01:00am on Friday and Saturday is the latest the police would accept.

We believe that the following additional measures are absolutely necessary to protect both customers, staff and help to promote the prevention of crime & disorder objective.

CCTV will be installed and maintained at the premises to the satisfaction of the Licensing Authority and Police. As a minimum it will enable surveillance of both internal and external areas of the premises including all entrances and exits. Recordings from the system will be to a standard acceptable as evidence in a court of law and will be securely retained for a minimum of 30 days.

The CCTV system will be capable of producing immediate copies of recordings on site and will be surrendered in a playable format to Hampshire Constabulary immediately on request. The system will be maintained and fully operational, as a minimum, throughout the hours that the premise are operating.

A minimum of two SIA registered door staff shall be provided on Thursday, Friday, Saturday (and any Sunday prior to a Bank Holiday) from 2300 until close of business. Door staff shall wear high visibility sleeved jackets, to BS EN 471 or equivalent standard (but not in yellow to avoid being mistaken for emergency services staff), with appropriate holders for SIA badges to allow clear identification. Their role will include the dispersal of customers both from within the premises as well as any congregating on the pavement/road directly outside.
