On 31 January 2007 Mr Moody was convicted for the use of Threatening abusive insulting words/behaviour or disorderly behaviour to cause harassment/alarm/distress. He was fined £100 and costs of £50 and further convicted on the 20 July 2007 and 16 November 2007 for breach of a community order. On the 2 November 2009 Mr Moody had been drinking alcohol during the afternoon in Eastleigh town centre. On leaving the licensed premises Mr Moody punched two men in an unprovoked attack at the bus station. In interview Mr Moody admitted to getting very drunk and punching both the males after viewing the CCTV footage of the assault. Mr Moody was convicted of Battery on 25 November 2009 at Southampton Magistrates Court and was ordered to pay £70 compensation, £85 costs and to carry out unpaid work for 60 hours within 12 months. On the 26 February 2010 Mr Moody's community order was varied as he failed to comply with the requirements of the original order imposed. Hampshire Constabulary believe that issuing a personal licence to Mr Moody would not be in accordance with Government Guidance or Council Policy, and it would undermine the Prevention of Crime and Disorder objective under the Licensing Act 2003. It is an offence, under section 158 of the Licensing Act 2003 to make a false statement in or in connection with this representation Police recommendations (including any conditions) Reject the application for a personal licence
