The proposed DPS is already a DPS for another town centre public house in the same area. It is unlikely that he will be able to have day to day running of both premises and therefore would not be able to enforce the licensing objectives to there full potential. The proposed application is for what the police would suggest is a 'challenging' public house and would require strong and focused management.

The police feel that the DPS of this public house should be focusing solely on this premise and not divide their commitments between two premises.
