Report of the Head of Legal and Democratic (Portfolio: Corporate)

#### Recommended to Council:

#### SUMMARY:

- The existing powers and duties of the Licensing Committee do not reflect the current areas of responsibility of the Committee.

#### 1 Introduction

1.1 The powers and duties of the Licensing Committee are approved each year in accordance with the Constitution by Annual Council. The current powers and duties appear as Annex 1 to this report.

2.1 Officers have reviewed the existing powers and duties and discovered that they do not accurately reflect the actual areas of work undertaken by the Committee. In particular the existing powers and duties refer to matters which are no longer the responsibility of the Committee, largely as a result of changes in legislation. Examples of this include registration of door supervisors and licensing of pools promoters. In order to ensure that the powers and duties reflect the actual areas of responsibility of the Committee it is recommended that they be revised as set out in Annex 2 to this report.

#### LICENSING COMMITTEE

#### Powers and Duties:

Subject to the Council's Constitution, the discharge of its functions as set out below:

- 1. Licensing functions set out in the Licensing Act 2003 and any amendments thereto
- 2. Licensing functions set out in the Gambling Act 2005 and any amendments thereto.
- 3. Hackney Carriages and Private Hire Vehicles, Drivers and Operators, Licensing and Registration.
- 4. Caravan site, moveable dwelling and campsite licensing.
- 5. Licensing of Pools Promoters, Track and Inter Track Betting, premises with amusement machines (with or without prizes) and lotteries.
- 6. Public Entertainment Licenses, licensing of cinemas, cinema clubs, theatres, sex shops, sex cinemas, performances of hypnotism, other entertainments and registration of door staff.
- 7. Health & Safety at Work Enforcement:
- 8. Animal control and welfare licensing including killing, selling and dealing in Game.
- 9. Slaughterhouses, rag flock filling premises, scrap yards, meat products, dairy and egg production premises, food preparation premises, poultry packing stations and knacker's yards registration and licensing.

- 11. To hear representations from

#### ITEM 8 Revocation of a Private Hire Driver's Licence

Report of the Head of Legal and Democratic (Portfolio: Corporate)

#### Recommended:

That it be noted that the Head of Legal and Democratic has suspended a Private Hire Vehicle Driver's Licence.

#### SUMMARY:

- The Head of Legal and Democratic has used his delegated powers to suspend a Driver's Licence as a result of the driver failing to submit an application for a criminal records disclosure.
- Members of the Licensing Committee have previously requested that they be informed of any occasions when refusals, suspensions and revocations occur.

#### 1 Introduction

1.1 The Head of Legal and Democratic has delegated powers to refuse applications for Hackney Carriage and Private Hire Vehicle Driver's Licences and also to suspend or revoke such Licences once issued. In this case the suspension of the Licence issued to Mr S Stone was based on the Council's licensing policy which requires drivers to undergo an enhanced criminal records check every three years. Members of this Committee have requested that they be informed of Licence refusals, suspensions and revocations.

#### 2 Background

- 2.1 For a number of years the Borough Council, in common with all other Hampshire authorities, has required Hackney Carriage and Private Hire Vehicle Drivers to undergo an enhanced criminal records disclosure, firstly upon initial application and then every three years thereafter. The purpose of the criminal records check is identify if the driver has been convicted of any criminal offence which would make them unsuitable to be licensed as a driver. It is over three years since the driver in question last underwent a disclosure. Despite being sent reminders and being given some months to remedy the situation, he has failed to do so. It is understood that he may no longer be driving but as a precaution Mr Stone has now had his licence suspended.
- 2.2 The legislation regarding the licensing of drivers allows the Borough Council to seek additional information. The policy of Test Valley Borough Council, along with virtually every other licensing authority in England and Wales, is that drivers undergo an enhanced level criminal records disclosure undertaken by the Disclosure and Barring Service.

Without a satisfactory disclosure report, the Borough Council cannot meet the requirement laid down in the legislation of being "satisfied that the applicant is a fit and proper person to hold a driver's licence".

#### **3** Corporate Objectives and Priorities

3.1 None; the licensing of Hackney Carriage and Private Hire Vehicle Drivers is a statutory function of the Borough Council. In deciding whether to grant a licence, the overriding consideration will be the protection of the public. As Hackney Carriage and Private Hire Vehicle Drivers are employed in a position of trust and may often carry unaccompanied passengers, the Council's policy is that applicants meet a number of requirements including provision of a satisfactory criminal records disclosure at an enhanced level.

#### 4 Consultations/Communications

4.1 None, other than communications with the driver concerned.

#### 5 Options

5.1 There are no alternative options as the Council's licensing policy states that drivers are required to undergo an enhanced criminal records disclosure.

#### 6 **Resource Implications**

6.1 There are no resource implications as a result of this report.

#### 7 Legal Implications

7.1 In accordance with the legislation, the driver had the right of appeal against the Head of Legal and Democratic's decision which should have been lodged with the Magistrates Court within 21 days of the driver being informed by the Council. No appeal was lodged

#### 8 Equality Issues

8.1 An Equalities Impact Assessment was undertaken when the policy mentioned in paragraph 2.1 above was first adopted in 2007.
