## **Hearings under the Licensing Act 2003**

## **Hearings**

Of 91 applications warranting a hearing, only 70 have taken place. The remainder have been resolved such that no hearing was necessary or the application was withdrawn. There have to date been ten refusals as detailed in the table below. In most cases applications have been granted but often with reduced hours than those requested or with conditions attached to the licence. There have been two appeals of a Sub-Committee's decision (Red Lion, Clanville and Tesco Express, Andover) which have been upheld. A further appeal (McColls, North Baddesley) was agreed with the applicant. Licences issued as at April 2017: Personal 1534; Club Premises 41; Premises 404.

## **Reviews**

Ten Reviews of a Premises Licence have taken place including two review hearings as a result of Police closure orders.

## **Temporary Events Notices**
