ITEM 4

Licensing Procedure Rules - Licensing Sub-Committee

Application

These Procedure Rules shall apply to all hearings of applications and other matters pursuant to the Licensing Act 2003 and subordinate legislation and any amendments thereto, and the Gambling Act 2005 and subordinate legislation and any amendments thereto.

Terms of Reference of the Licensing Sub-Committee:

1. Ward Members will have no involvement in the decision making process.

Procedure for hearing licensing applications:

- 1. The Council's Scheme of Public Participation will not apply.
- 2 At the start of the hearing the Chairman will explain the procedure to all those present.
- 3. The Hearing shall take place in public. The Sub-Committee may exclude the public from all or part of the hearing where it considers that the public interest in so doing outweighs the public interest in the hearing, or that part of the hearing, taking place in public.
- 4. A party to whom notice has been given may attend the hearing and may be assisted or represented by a person whether or not that person is legally qualified.
- 5. The hearing shall take the form of a discussion led by the Sub-Committee.
- 6. Cross-examination will not be permitted unless the Sub-Committee considers it is required for it to consider the representations, application or notice as the case may require.
- 7. The Sub-Committee may impose a maximum period of time for each party to address the Sub-Committee.
- 8. To facilitate the discussion the following procedure will be followed in all cases except for reviews when 8(b) shall apply and interim steps hearings for expedited summary reviews when 8(c) shall apply:
 - (a) (i) The Licensing Manager of the Council or their representative will present the facts of the application and action taken, to the Sub-Committee.
 - (ii) The Applicant or their representative may address the Sub-Committee.

- (iii) Other parties may address the Sub-Committee in the following order:
 - Responsible authorities
 - Other parties
- (b) (i) The Licensing Manager of the Council or their representative will present the facts of the review, and action taken, to the Sub-Committee.
 - (ii) The person requesting the review may address the Sub-Committee.
 - (iii) The licence holder may address the Sub-Committee.
 - (iv) Other parties may address the Sub-Committee in the following order:
 - Responsible authorities
 - Other parties
- (c) (i) The Licensing Manager of the Council or his representative will present the facts giving rise to the review, and will outline any action taken, to the Sub-Committee.
 - (ii) The Police officer requesting the review or his representative may address the Sub-Committee.
 - (iii) The licence holder or their representative may address the Sub-Committee.
- 9. The Sub-Committee may permit the applicant or any party to question any other party.
- 10. The members of the Sub-Committee may ask any questions of the Licensing Manager or their representative, or of any party or other person appearing at the hearing.
- 11. Documentary or other evidence may be produced at the hearing with the consent of all the parties.
- 12. Where a party fails to attend or be represented and the Sub-Committee considers it necessary in the public interest it may adjourn the hearing to a specified date or hold the hearing in a party's absence.
- 13. The Sub-Committee may require any person attending the hearing who in their opinion is behaving in a disruptive manner to leave the hearing and refuse to permit that person to return or permit them to return only on such conditions as the Sub-Committee may specify. Any such person may submit to the Sub-Committee in writing before the end of the hearing any information which they would have been entitled to give orally had they not been required to leave.

- 14. The Sub-Committee may ask questions of its legal adviser.
- 15. The Sub-Committee will deliberate in private.
- 16. The Sub-Committee may request advice in private of its legal adviser regarding the drafting of reasons.
- 17. In the case of a hearing under the sections and circumstances set out in Regulation 26(1) of the Licensing Act 2003 (Hearings) Regulations 2005 (or any amending legislation), the Sub-Committee will make its determination at the conclusion of the hearing.
 - In any other case, the Sub-Committee will make its determination either at the conclusion of the hearing or within the period of five working days beginning with the day or the last day on which the hearing was held.
- 18. A record of the hearing will be taken in a permanent and intelligible form.

ITEM 5 Application for a new Premises Licence – Keepers Lodge, Whinwhistle Coarse Fishery, Whinwhistle Road, East Wellow, Romsey SO51 6BE

1 The application

- 1.1 The application is by Woodington Fisheries (2020) Limited for a Premises Licence in respect of premises at Keepers Lodge, Whinwhistle Coarse Fishery, Whinwhistle Road, East Wellow, Romsey SO51 6BE. The application as submitted seeks provision of live music, recorded music and supply of alcohol for consumption on and off the premises from 0800 to 2300 hours Monday to Sunday inclusive (NB the initial application incorrectly showed sale of alcohol until 2330 hours but the applicants have confirmed it should be 2300) with an extension on New Year's Eve until 0030 hours.
- 1.2 The application has attracted representations objecting to the application which necessitates it being determined at a hearing. A copy of the application is attached as Annex 1 to this report. Following submission of the application the applicants subsequently provided a document setting out their rationale for seeking the licence as well as proposing some conditions to be attached to any licence if granted; this appears at Annex 2 to this report.

2 Background

2.1 The premises are described in the application as an "existing café/bistro single storey, mono-pitch structure with full length bi-fold doors, level access via a 900mm door during the colder months/wet weather. The premises is in a rural location, no neighbours, wc/wash facilities via separate access, internal seating for 28 people, external café patio area/beer garden".

3 Promotion of the Licensing Objectives

- 3.1 The applicant makes the following comments in relation to the steps taken to promote the four licensing objectives. These comments are taken directly as entered in the application:
 - a) General The licensee will ensure there are sufficient competent staff on duty whilst the premises is open for licensable activity. This is for the purpose of fulfilling the terms and conditions of the licence and for preventing crime and disorder. All staff will undertake appropriate training for their responsibilities in relation to the sale of alcohol, especially with regard to drunkenness and underage persons. All training will be kept on record and refreshed when due or needed. A first aider will be on site.
 - b) The prevention of crime and disorder The Licensee will ensure: staff check proof of age; CCTV system will be installed; no glass to be taken beyond the beer garden; limit capacity of customers to avoid overcrowding; first aider available.
 - c) Public safety The Licensee will ensure: appropriate fire extinguishers, procedures, fire exit signs and emergency lighting are in place; disabled access [is] clearly visible; not responsible for property/vehicles signs to be

- in place; proof of ID signs to be in place and clearly visible; staff to keep on top of removing glass from tables, etc.
- d) The prevention of public nuisance The Licensee will ensure: please leave quietly signs to be in place; litter picked and bins emptied daily (internal bins); any music is turned off by licensed times; light pollution controlled i.e. flood lights, sign lights.
- e) The protection of children from harm The Licensee will ensure: staff ask for ID proof of age; staff are trained for underage sales prevention; under 18s are accompanied by an adult over 18; no under 18s allowed to sit at the bar.

The measures to promote the licensing objectives are of relevance when considering the representations received. As mentioned in paragraph 1.2 above the applicants have subsequently submitted revised information and this includes revisions to some of the above comments. These are set out in Annex 2 to the report.

- 4 Relevant Representations Responsible Authorities
- 4.1 **Hampshire Fire and Rescue Service –** does not wish to make any representations.
- 4.2 **TVBC Housing and Environmental Health** the Environmental Protection Team has raised no objection and makes the following comments: The times of the live and recorded music which have been applied for are such that no licence is required for these activities and therefore this service can have no objections to the application in terms of upholding the licensing objective, Prevention of Public Nuisance. Having said that, the scale of the entertainment (for around 60 customers) and the proposed conditions from the applicant are such that significant impacts seem unlikely. Should issues arise, however, this service has powers under the Environmental Protection Act to deal with noise nuisance and a review of the licence can also be called for.

- 5.2 It should be noted that some objections refer to the impact upon wildlife and animals. These comments should be disregarded as public nuisance is an act that is illegal because it interferes with the rights of the public generally; as local wildlife cannot be classed as the public any comments relating to the impact on flora and fauna are not relevant and should not be considered. Some objectors also question the need for additional licensed premises which again is not relevant to the licensing objectives and so should not be considered. Any comments about the lack or otherwise of appropriate planning permission should also be discounted as the absence of the correct permission is not in itself a ground for refusal of the application.
- 5.3 In addition, 39 representations were received in support of the application and appear in Annex 30 to this report.

6 Policy Considerations

- 6.1 The representations raise concerns relating to aspects of all four licensing objectives. It is therefore considered that the following extracts from the guidance issued by the Secretary of State under section 182 of the Licensing Act 2003 (December 2022 edition) are relevant.
 - 2.1-2.6 Crime and disorder
 - 2.7-2.9 Public safety
 - 2.15-2.21 Public nuisance
 - 8.41-8.49 Steps to promote the licensing objectives
 - 9.1, 9.3-9.12, 9.31-9.44 Determining applications

7 Observations

- 7.1 The Committee is obliged to determine this application with a view to promoting the four licensing objectives of prevention of crime and disorder, public safety, prevention of public nuisance and the protection of children from harm. In making its decision, the Committee is also obliged to have regard to the national Guidance and the Council's own Statement of Licensing Policy. The Committee must also have regard to all of the representations made and the evidence it hears. The Committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - a) Grant the application as requested
 - b) Modify the conditions of the licence, by altering or omitting or adding to them. (The Committee may where appropriate attach different conditions to different parts of the premises concerned and/or to different licensable activities).
 - c) Reject the whole or part of the application (for example by allowing only some of the licensable activities or permitting them to take place at times other than those requested).

The Committee is asked to note that it may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote one or more of the four licensing objectives:

- a. Prevention of crime and disorder
- b. Public safety
- c. Prevention of public nuisance
- d. Protection of children from harm

Notes for Guidance

Whinwhistle Fishery – Premises Licence application

Reason for application

The primary reason for the application is to be able to sell alcohol to caravan and motor homers staying on site, fishermen using the lake and visitors to the cafe (many of whom regularly ask for alcohol as an accompaniment to their order). Many local residents who come in to use the cafe also request the same. The premises application seeks only to license the cafe/bistro and the outside seating area. Where the application requests sales of alcohol for consumption off the premises, this is purely to allow the occupiers of caravan and motor home pitches and anglers who are staying overnight to be able to purchase alcohol which they can then consume back at their caravan, etc. There is no intention for the site to operate as a general off licence.

As for concerns about noise/loud music, a countryside pursuit like a fishery would be unable to operate with loud music as it would deter customers. It should be noted that alcohol has been consumed since the fishery's opening well over 20 years ago – as members of the public bring it with them on their vacation/day trips – and during this time not a single incident of any concern has occurred.

Proposed conditions

- 1. Licensable activity shall not be provided at any event which is described as or could be considered as a rally, festival or large event to which the general public might have access.
- 2. Licensable activity shall only be provided within the building and external seating area and will not be permitted in any additional buildings or marquees in other locations around the Fishery.
- 3. All staff engaged in the sale of alcohol must be trained on their responsibilities in preventing the sale of alcohol to persons aged under 18 and those that are drunk. In this respect the premises will operate a Challenge 25 policy.
- 4. Live music provided externally shall be incidental or offered in such a way that it is not the primary attraction and the premises should consider restricting activity to that provided by a choir, acoustic guitar, keyboard or small band. In any event all external music shall cease by 2200 hours. Live music will be provided on no more than four occasions in any one calendar year.
- 5. Irresponsible drink promotions will not be allowed.
- 6. All licensable activity at the premises will be managed by the premises staff/management/owners i.e. responsibility shall not be passed to any third party.
- 7. High strength, cheaper alcoholic products commonly described as alco-pops and similar will not be sold. High-strength beers, ciders and lagers in excess of 8% ABV will not be sold.

- 8. Sales of alcohol will be restricted to campers and occupiers of caravans and motor homes, persons using the fishing lake and customers of the café i.e. the premises will not operate as a general off licence.
- 9. Children aged under 16 years of age must be always accompanied by an adult. Children and young people under 18 years of age are not permitted to sit at the bar.

As a near neighbour of Whinwhistle Coarse Fishery and a long-term resident of the area, we wish to inform you of the severe disturbance and possible lawlessness that approval of this application would create to the immediate locality, several neighbouring residential properties, and St Margaret's church.

The Blackwater river valley in this area is a tranquil rural space well suited to quiet country pursuits such as fishing, and indeed limited camping. It is consistent with this that the site also provides a fishing tackle shop and a café to serve its customers. It is also true that these services do not disturb the amenity of neighbouring properties.

It is equally true that both the "Provision of live and recorded music from 0800 to 2300 hours daily indoors and outdoors", and the "Sale of alcohol for consumption both on and off the premises from 0800 to 2330 hours daily" are completely inconsistent with the current use and will be severely detrimental to the immediate site and the wider locality.

Whatever the intended use it will be very different, for example outdoor music events and festivals come to mind. It will encourage crime and disorder at a location that is incapable of managing and controlling a large influx of people who would see this as a great site for a "rave", with all the attendant risk of drunkenness, drugs, pollution of the river, desecration of the countryside etc. With the Police already overloaded this is something they could do without.

It will impact public safety as the entrance to the site is narrow and with restricted visibility on to Whinwhistle Road. There are already dangerous tailbacks here just waiting for the site to open in the morning.

It will create a public nuisance through overspill from on-site activity and from noise pollution to neighbouring properties and St Margaret's church. We are not the nearest neighbours but are well within the zone of sound disturbance from such activity.

We also note there has been no associated Planning Application for the change of use or additional facilities that would clearly be needed.

This application should be refused.

Dear Mr White,

In response to your email our official objection dated 12 April 2023 and the reasons for objecting remain, but we'll comment informally on the proposal and conditions you forwarded to us. Our main concern is the <u>unintended consequences</u> of any licensing of music and / or alcohol at this location. We simply do not believe that the applicants, however noble their intentions, will be able to control a large influx of people knowing of the licensing situation, arriving at the site seeking to abuse the hospitality and creating a public disturbance of the sort mentioned in our formal response. Given the remoteness of the location, if such a situation arose even a 999 call is unlikely to trigger a sufficiently timely police intervention.

Wellow, and in particular the rural area in the north of the Parish, is mercifully "off the beaten track" so unwelcome behaviour, particularly from outsiders, is not a problem today, but it will only take a single breach to destroy this for ever. The majority of the people who live here chose to do so specifically for its isolation and have been here (like us) for many years. Several of them have told me they share this concern and I hope they have also voiced it to you. Others simply do not know of this application (indeed we only learnt of it by chance). While Mr and Mrs Hawthorne are very welcome newcomers to the locality they may not fully appreciate its heritage and the fragility of this heritage.

To address the specifics:

- 1. When it comes to licensing law we are laymen: we understand the basics of an off-site license vs an on-site alcohol licence and an indoor vs outdoor music licence, but it appears from your response that you can authorise a bespoke solution. Is that true?
- 2. With respect to the music license, if the request is for no more than four outside events per year, then in order for that to be policed, and for neighbours to be forewarned, it would be more appropriate for each event to be applied for at the time, rather than authorising an unpoliceable arbitrary number with no specified dates. In terms of noise transmission, we point out that when Broadlands hosts an outside event we hear it, so the potential for disturbance from this much closer location is high.
- 3. With respect to the alcohol license there appear to be three groups of customers: (i) people registered and camping on-site, (ii) people registered and fishing on-site and (iii) outsiders who visit the café (no numbers have been provided so we have no idea how relevant this group is). There is also a question over whether this café is (as the applicant states) also a restaurant ("bistro" is the term used). We suspect a restaurant would require Planning Approval as well as other licensing / registration permissions to operate: does this site have any of these approvals? We can see why an approved restaurant would wish to serve beer or wine with a meal, but given the stated objectives for the site and the reasons for the application we see no reason for any higher level of alcohol content or off sale. With just a café, however, the status quo appears to work well already: Campers visit local shops for provisions anyway, and Fishermen are on a day visit and normally bring their own provisions.
- 4. Overall the risk of unintended consequences remains too high.

Dear Licensing Manager, I share a significant land boundary with Whinwhistle Coarse Fishery and a long-term resident of the area. I wish to inform you of the severe disturbance and possible lawlessness that approval of this application would create to the immediate locality, many neighbouring residential properties on Romsey Road and Hackleys Lane . Also wider noise disturbance to residents of Wellow Village and St Margaret's church.

The Blackwater river valley in this area is a tranquil, I rural space well suited to quiet country pursuits such as fishing, and limited camping connected with fishing activities. It is consistent with this that the site also provides a fishing tackle shop and a café to serve its customers.

As it stands these services do not disturb the amenity of neighbouring properties. However both the "Provision of live and recorded music from 0800 to 2300 hours daily indoors and outdoors", and the "Sale of alcohol for consumption both on and off the premises from 0800 to 2330 hours daily" are completely inconsistent with the current use and will be severely detrimental to the immediate site and the wider locality.

I am concerned about the extreme noise disturbance to a quiet area of countryside bordering the Black water river. Sale of alcohol and music until late at night would encourage drunkenness, possibly drugs and pollution of the river. The noise pollution would be horrendous for the local wildlife and residents. Usage could also creep towards outdoor music events and festivals.

The access to the site is narrow with restricted visibility on a difficult junction, known locally for its high rate of traffic accidents. Regarding Woodington Rd, It is a matter of public safety – Cyclists, Horse riders and walkers already take their lives in their hands on that section of road.

There are already dangerous tailbacks here just waiting for the site to open in the morning. It will create a public nuisance through overspill from on-site activity and from noise pollution to neighbouring properties and St Margaret's church.

I also note there has been no associated Planning Application for the change of use or additional facilities that would clearly be needed. **This application should be refused.**

Dear Michael

Thank you for your email detailing the restrictions.

To date the cafe and camping operation at Wellow Fisheries has been low impact and appropriate for a rural, riverside location.

Campers are able to purchase supplies and alcohol from two local shops in the village, which is good for the local businesses. There are also two other established local cafes.

I see no advantage to the local area of selling alcohol on the premises. Local ,non-fishing , traffic to the cafe is very minimal, if at all. There is already a very well supported cafe at Headlands Fisheries which is situated more conveniently in the middle of the village and an incredibly busy cafe and ice cream parlour at Carlos just around the corner from the Fisheries entrance.

Re live music, this doesn't seem to relate to the core operation on the site, which is Fishing. There are a lot of fishing lakes locally which all take a lot of care to preserve the quiet nature of their environment for the pleasure of this country pursuit. The core activity of Wellow Fisheries is Fishing, which is, by its nature, a very quiet sport. I have huge concerns about the effect on the riverside wildlife if any live music or noisy evening activity's were introduced into the environment. It also seems to go directly against the wider reasons why people fish - they appreciate the natural, quiet environment.

As a local resident of over 30 years, that shares a boundary with the Fisheries, I am resistant to any increase in activity that will threaten the peace of the wildlife and the local environment.

We are able to hear very well any music at Broadlands and the folk festival In Landford, both several miles away. Also, the agricultural workers living in caravans situated on Tutus Lane, (1.2 miles away) sometimes play music and that is clearly heard in our garden.

We live near St Margaret's Church, which is elevated from the river and village. Sound travels up the hill and we already hear clearly voices and louder play during football matches on the grounds in the middle of the village, over a mile away. This is all during the day and part of a positive village life.

Wellow Fisheries is much closer to us and I value highly quiet afternoons and evenings sitting outside. We would definitely be able to hear music, played inside or out and it would ruin the experience having someone's bass line pounding in the background.

We have spent decades planting trees, developing marginal woodland and grassland to encourage wildlife. We have two resident barn owl families, king fishers and a few ground nesting species too. All of these birds and the accompanying wildlife require a quiet, undisturbed environment which we wish to preserve. For all of the above reasons, my objection stands.

Thank you for the attachment.

The reasons for my objection, as set out in my email of 19 April 2023, remain. My concern is also the unintended consequences of any licencing of music and/or alcohol at this location.

There is nothing in place to control a large influx of people knowing of the licencing situation (*ie the sale of alcohol for consumption both on and off the premises from 0800 to 2330 hours daily*) from arriving at the site at any time up to 23.30 at night to purchase alcohol to consume off the premises, and in doing so create a public disturbance. Given the rural location and police response times to current unlawfulness in the countryside (theft, burglary etc), there is no guarantee if a public disturbance or any other unlawful event arose that any 999 call would result in a timely police response.

The wide drafting of the proposed licence permits events (rallies, music festivals etc) where there would be public access. If Conditions can be attached to the licence then there should be a maximum limit of 3 or 4 events per annum. These events should be advised to Wellow residents, particularly close neighbours, and approved on an individual basis in advance rather than authorising an un-policeable number of events with no specified dates.

Noise transmission is another concern and a Condition should be set on the level of noise permitted at any event. I live about 0.5 miles (possibly less) as the crow flies from the location of the New Forest Folk Festival's stage and can hear the music, even inside my house, when the festival is on. There are neighbours of the Fishery who are even closer than 0.5 miles as the crow files who will, without doubt, suffer noise disturbance from any outdoor events at the Fishery. The general amenity of the area (including the peace and tranquillity of the countryside) which Wellow residents currently enjoy must be considered, and Conditions must be set to protect them from noise and crowd disturbance if any licence be granted.

If the current situation regarding the café works well and fishermen and campers bring their own alcohol on site for consumption why is there any need for an alcohol licence? The café's menu itemises hot breakfasts, hot and cold drinks, cakes, confectionery and ice creams etc. The selling of alcohol, with or without meals, at the café suggests that something more than a small café is planned for the site. If it is the intention for a bistro/restaurant selling alcohol at the site wouldn't the restaurant/bistro require planning permission?

The applicant's website is promoting a Fishery in a "beautiful, mature and natural Hampshire setting". It is an area of peace and tranquillity within the River Blackwater River Wildlife Corridor, close to SSSI's, a Ramsar site and within the Mottisfont Bats SAC buffer zone. The River Blackwater feeds into the River Test and the Fishery acknowledges that sea trout are known to run through the stretch of the River Blackwater which flows through the Fishery. As well as the major concerns for Wellow residents of the direct impact and unintended consequences of proposed music and alcohol licence, the need to protect the environment also needs to be taken into consideration.

This application should be refused.

I wish to object very strongly to the application for a Premises Licence by Woodington Fisheries (2020) Limited in respect of Keepers Lodge, Whinwhistle Coarse Fishery to provide:

- 1. Live and recorded music from 0800 to 2300 hours daily indoors and outdoors; and
- 2. The sale of alcohol for consumption both on and off the premises from 0800 to 2330 hours daily.

The site is a fishery in natural pastures and flood meadows adjoining the River Blackwater in a rural area. The existing on-site facilities of a fishing tackle shop and a café for the fisheries' customers do not cause any disturbance at the present time, however the proposal for a new licence for live and recorded music from 0800 to 2300 hours daily indoors and outdoors and the sale of alcohol for consumption both on and off the premises from 0800 to 2330 hours daily is totally inconsistent with the current use of the site. The hours proposed for the two parts of the licence (music and alcohol) are excessive for what is a rural, tranquil area.

The new licence will encourage more noise and be a disturbance to neighbours and others in the surrounding area, which includes St Margaret's Church where Florence Nightingale is buried. This licence, if approved, could include outdoor music events and festivals at a location which is incapable of managing and controlling a large influx of people. There is nothing in the licence application to restrict noise levels (eg no maximum decibel level has been set) and there is no restriction on the numbers of events which will be held. Outdoor music events and festivals are often associated with unlawful behaviour such as drunkenness and drug taking, noise pollution and the environmental pollution of the countryside. How will this be policed?


There is also a public safety risk as the site entrance is narrow with restricted visibility. There are often tailbacks in the area with water/flooding/mud on the road, and traffic turning on and off Woodington Road into and from the fishery, Romsey Road and Ryedown Lane. Large lorries use Woodington Lane (often as a short cut from the A36 to the A27) and, if flowing freely, the traffic is often travelling at speeds which are too fast for the road conditions.

When it becomes known that alcohol is for sale for consumption on and off the site, how will the safety of any pedestrians walking to the site, possibly in the dark in winter months, be maintained when there is no footpath?

This licence application should be refused to prevent crime and disorder, prevent a public nuisance, ensure public safety and protect children from harm.

The premises are an existing café / bistro located on a fishery and camping site. The application also includes an external beer garden area. The application seeks:

- 1. Provision of live and recorded music from 0800 to 2300 hours daily indoors and outdoors.
- 2. Sale of alcohol for consumption both on and off the premises from 0800 to 2330 hours daily.

Grounds for Objection

As a long-term resident living in close proximity to Whinwhistle Coase Fishery we have a number of significant concerns relating to the proposed application for the new Premises Licence. These areas of concern extend to the following:

- 1. The lack of justification for the proposed Licence within open and rural countryside which will result in significant noise disturbance to local residents and school children;
- 2. The impact of the proposal on highway safety;
- 3. The impact of the proposal on the environment;
- 4. The lack of Public Consultation and an associated Planning Application.
- 1. The lack of justification for the proposed Licence within open and rural countryside which will result in significant noise disturbance to local residents and school children.

The provision of live music and a beer garden (serving alcohol) from 0800 to 2300 will result in severe noise disturbance to local residents who live in a quiet and residential area which is within open and rural countryside. The fishery is located on a residential street with many families with young children and is also in close proximity to the local primary school and St Margaret's Church. It is the very rural nature of the environment that residents find attractive and the prime reason why people choose Wellow as a place to live.

The application is therefore not in keeping with the rural and residential nature of the area and the noise pollution would be detrimental to the health and wellbeing of local residents.

From personal experience, when parties and events have been held previously at Keeper's Lodge, the amplified music rolling across from the fishery site to Romsey Road is clear, loud and disturbing. These parties have been relatively infrequent in the past but the idea of more regular disruption is unacceptable.

2. The impact of the proposal on highway safety;

The access to the site is narrow with restricted visibility on a complex and problematic junction known for its high rate of traffic accidents. The road is also used by many cyclists and horse riders. The application will result in increased traffic flow and traffic congestion, endangering public safety.

3. The impact of the proposal on the environment

Increased traffic, air and noise pollution will endanger and disturb local wildlife in an area rich in flora and fauna. The parish has a wide diversity of animals which reflects the varied habitats including badgers, deer, foxes, squirrels, bats, and the endangered water vole along the River Blackwater.

Any application for a proposed 'change in use', should not damage the rural environment.

4. Lack of Public Consultation and Associated Planning Application

There has been no public consultation or Planning Application submitted for the change in use or additional facilities that would be required.

It is considered that the proposal does not accord with Policy LE16 of the Test Valley Local Plan as care needs to be taken to ensure that uses ancillary to the new use of the building, such as car parking and open storage do not have an intrusive impact on the rural environment including the extensions of the curtilage of the development into the countryside. Account will also be taken of amenity issues such as noise, smell, or over-illumination.

The development would also create unacceptable visual harm to the area which would not integrate, respect, or complement the local character and would lead to increasing the urbanisation of the locality, to the detriment of the rural setting.

We have lived on Romsey Road since 1997; we appreciate - and are very proud - of the value this village of Wellow places on the River Blackwater, its surrounding woodland and agricultural fields, it is a special area of diverse wildlife and plant species. We have something of enormous value here and it must be protected.

Should this application be successful the noise will be a classic public nuisance issue covering a wide area and will also have an adverse effect on the Wildlife which normally inhabits the banks of the River Blackwater. This is of particular importance as Wellow is a 'shoulder' village to the New Forest National Park and as such has a fluid exchange of the wildlife found within the Park. As householders we will hear any music from this venue, it is very close to all neighbours on Romsey Road, particularly those whose gardens flank the adjacent field and river. The selling of Alcohol changes completely the use of the Fishery into a party venue.

I would like to make some comments about the above Fishery application for selling alcohol and the provision of live music at Keepers Lodge.

The services offered by Woodington Fishery at present do not cause me any disturbance and indeed I feel the business is a good asset to the area.

BUT I have concerns about what is being proposed.

1. The site lies within an unspoiled rural area and AONB which at present enjoys tranquillity and calm. Consumption of alcohol leads to jollity and an inability of people to control the volume of their voices. Any motivation to moderate noise levels will be low, especially if the drinkers think that they are far away from other people. This, however, does not take into account that noise travels widely in open spaces and carries on the wind. The Keepers Lodge is located near to several outlying residences and one village, the inhabitants of which will inevitably hear any noise, be this from voices, live or amplified music, or extra vehicle traffic. This is a public nuisance.

The proposal to not only serve alcohol with a meal, but also at a bar opening into the wee small hours of the morning, will inevitably lead to noise at unsociable times and will disturb local wildlife. Serving alcohol late would also require more lighting and light pollution in the area. I have a major concern of noise of traffic leaving at late hours.

Prevention of Disorder

Members of the public without a booking can be expected to visit the site on a Friday or Saturday evening in the summer to purchase drinks and to enjoy the music. If they are refused service it is likely that arguments will occur which may put staff and guests at risk. Site would need to be controlled. I am assuming the alcohol license and music is for booked guests only.

I live very close to Woodington Fishery and I would expect businesses to respect local residents and listen to our concerns and we in return would support and respect them.

I ask that this application be refused.
