It has come to my attention that an Acer pseudoplatanus (Sycamore) in Riverside Gardens has had an application for the tree to be felled and removed, since when a temporary TPO has been placed on the tree pending its removal or having a permanent TPO being placed on the tree, with various appeals and representations on both sides.

Considerations for the TVBC to take into account.

I'm a resident of years and a frequent visitor to my house of over years living in Middlebridge Street and whose garden backs onto Riverside Gardens.

The aforementioned tree is probably over 70 years old and was more than likely planted by Cyril Chapman when he had his nursery on the land now occupied by the Riverside Gardens development.

For someone or people now to disapprove of its existence should be irrelevant. The mature tree was there at the time of the developer getting planning to build his houses (nearest to the tree) in the late 1980's or early 1990's, if it was felt the tree was to cause a nuisance, surely that would have been the time to request for it to be felled, not 30 years later! Having looked at the tree closely I can see no cause as to why the tree should be felled, it's not touching the building, in fact the canopy of the tree must be a good 10 metres from the building. The only small cause for concern is that the tree root is causing some lift in the adjoining pavement, but it's a long way from causing a trip hazard. The tree is in a healthy condition and has stood up to the ravages of storms and high winds since the 1980's. Then we have to add in the benefit of what this tree brings to wildlife, which has to be immeasurable.

Riverside Gardens which was built in 1966 is a very bland development with little or no landscaping to enhance it, apart from the properties facing the river. It has no established trees on the development; this Acer is the last of the mature trees to remain. There have been 3 mature Acers felled since the beginning of the 1990's (photo attached), so to have the last one remaining felled because people don't like, surely is not a reason for it to be felled – it has to be preserved!

Having been made aware that the tree in question has been made the subject of a temporary Tree Preservation Order (TPO), Romsey and District Society wishes to state its strong support for the preservation order becoming permanent. In a relatively high-density housing area this perfectly healthy and mature tree offers significant visual amenity value to the local community.

The Society believes that the subject tree **must** be preserved for its natural life span.

The tree in question is also the subject of a notice 20/03009/TREES to fell the T1 Sycamore Tree on the land between 69 to 72 Riverside Gardens and Public Pavement SO51 8HN. This notice identifies three issues in favour of removing the tree. None of them can be considered relevant to invalidating a TPO. They are:

- a. Damage to drains. There is no verification that the photographic evidence relates to a specific drain. If there is visible root growth within the drain it should be removed.
- b. Damage to the pavement. Current damage is minor but does not affect wheelchair users. There is room to alter the pavement layout such that its surface would be less at risk of damage.
- c. Potential damage to parked vehicles. The risk of falling limbs can be avoided by tree surgery. There is no evidence provided of any past vehicle damage related to this tree.

Please note that the above comments are entirely those of the Romsey and District Society Planning Committee and you may receive other comments from the Natural Environment Committee of RDS. Please record and consider the points of each RDS committee separately.

It's location alongside the public pavement means that it is very visible to and appreciated by many residents and contributes to the street scene and immediate surrounding area.

It links the trees in the Memorial Park to the trees at Broadlands providing a wild life corridor, with roosting and shelter for birds, pollen and nectar for bees and food for moths, attracting aphids and their predators.

Dear Sirs, I write once again to support the placing of a permanent TPO on this sycamore tree in Riverside Gardens. This tree, which has been there for at least 50 years to my knowledge, is the last one in a line of mature trees which has been felled because of the new builds in this area and, as such, it is very valuable to the local birds and insects and small mammals but also to the local inhabitants. It helps to stop climate change by absorbing large quantities of water - this is most necessary in this part of Romsey and by absorbing air pollution which has increased because of the high number of cars in Romsey but especially within the small environment of Riverside Gardens. It provides shade and shelter for birds and small animals. For human inhabitants it provides some relief in breaking up the outlook of the mass of buildings and tarmac and giving us something restful to look at. As far as I know the tree does not pose any threat to the people who live around it, true there is a very small crack in the pavement probably caused by a surface tree root but I am advised that this can be easily remedied. I myself have never seen any evidence of large branches being blown down, nor have I seen any evidence of the intrusion of tree roots into nearby drains and I would have thought that, when nearby properties were built, the builders and the water board would have taken all these things into consideration.

I would like to support the application for a TPO issue on The Sycamore tree in Riverside Gardens.

The tree causes minimal damage the pavement area. Freedom of information request to HCC shows zero complaints or damage caused by the path under the tree.

Going forward, root pruning and resurfacing of the pavement can easily be done if the path becomes damaged by tree roots.

The tree causes no damage to underground water pipes. The original applicant's photos of water pipes, 17th Nov 2020, I spoke to the water board inspectors that were onsite that day and they confirmed verbally to me that "there was no leaks found in the area".

The tree provides a valuable green corridor for birds and wildlife. Within the last year I have seen Tawney owls in it, Merlin bird sat on a wall 15 meters away, lots of bats in the area, this tree helps join up the north and south of the town.

If this tree were felled in my experience the roots in the surrounding area die down and cause considerably more soil movement than if the tree were living. When tree roots rotdown in the soil this also leads to underground channels which the likes of rats can swiftly adopt!

Riverside gardens is very near the water table and lots of trees have been felled in this conservation area in recent years, current FOI request lodged to find out how many.

This tree is the last of it's size in a vast area tarmac and concrete which is a conservation area, therefore in our battle against climate change this tree should be protected for the future.

Further to planning application 20/03009/TREES - Land Between 69 - 72 Riverside Gardens and the Public Pavement, SO51 8HN - T1 Sycamore - Fell, I understand that as a consequence of this application a provisional TPO has been placed on the tree in question.

I believe very strongly that the Sycamore tree <u>must be retained</u> and protected by having a permanent TPO placed upon it.

No evidence or specialist reports has been provided by The Riverside Gardens Tree Removal Group to support the reasons put forward in favour of removing the tree:

Damage to pavement - current damage is very minor and is restricted to a small part of the pavement closest to the tree. The pavement width is more than sufficient for pedestrians, those with pushchairs/walking aids and users of mobility scooters

Damage to pipework serving surface water drainage on private driveway by No. 69

Riverside Gardens. The first time in years any maintenance/cleaning of this drain was undertaken was in November 2020. Drains should be regularly maintained. Drains can be repaired. The comment that 'suspicion' that the tree roots may have damaged the pipework to the drain serving the public highway is pure speculation. There is no evidence of, and never have been any drainage problems to the public highway in the vicinity of the tree.

Risk of tree root damage to nearby buildings - the Sycamore pre-dates the construction of 69 - 72 and 75 - 78 Riverside Gardens. It is presumed that the designs for the properties took account of the nearby tree, more especially as the ground conditions are not of shrinkable clay. If evidence is provided in the future to link subsidence damage to the tree, then an application can be submitted to carry out works.

Shedding of large branches in last two storms - no large branches have ever been shed by this tree (neighbour of years). Dermot Cox, Arboricultural Manager at TVBC confirmed there was no visual evidence to support this claim at a site meeting on 15th March 2021.

In support of a permanent TPO being placed on the Sycamore tree I would add:

the tree is due north of 69 - 72 Riverside Gardens so cannot block natural sunlight. The nearest dwellings are also set back from the tree

the tree is a skyline feature with a high amenity value. All the points I made in the submission to place a provisional TPO on this tree are still valid but to summarise:

- The tree has an amenity value in that it is the only mature tree of any size in Riverside Gardens and visible to nearly all residents from their homes.
- The tree was a mature specimen before the dwellings (number 69 72) were built and suitable drainage should have been installed at the building stage to prevent root ingress.
- The tree is unquestionably a site sustaining several wildlife species, some wholly dependent on the sycamore as a food source.
- The value of trees as a carbon sink is well documented.
- There is no visual evidence of branches being shed by the tree as is claimed.
- The claim that the footway is so damaged that pedestrian passage (especially by push chairs et al) are obviously untrue as visual inspection supports.
- There appears to be little or no specialist, professional reports available to support the claims made by the Tree Removal Group.

As an additional point, if this tree were on the Hillier Arboretum, it is possible it would be considered as a specimen tree or possibly even a Champion Tree as mature sycamores are relatively uncommon.





The reasons given in the original application for the felling of the tree have absolutly no substance and are flimsy at least with no supporting evidence or professional reports supplied.

- 1. Regarding large branches falling on cars, No evidence has been submitted to substantiate any of these claims.
- 2. The tree being too close to the neighbouring properties. No evidence provided to back up this claim.
- 3. Describing the ripping up of the payment is an exaggeration to say the least. This is not a very busy path or road and the slight lifting of tarmac at the edge of the path could easily be rectified. The pavement width is more than sufficient for pushchairs and mobility scooters to use due to its 160 cm width. As for it being a trip hazard, as far as I am aware there have been no cases of people tripping and suffering injury? Once again, no evidence to support this claim.
- 4. As for the drain, have there been any issues of flooding caused by root intrusion? Once again, no evidence has been submitted. I have been informed that a drain sleeve could be inserted?

The sycamore is a life raft for wildlife in an area with shockingly few mature trees, supporting biodiversity at all levels from plants, fungi, insects, birds and small mammals to apex predators like the peregrine falcon. Wildlife has declined by 70% since 1960; no habitat is too insignificant to save.

In the midst of an accelerating climate emergency, we also cannot continue to add fuel to the fire by felling these precious carbon stores. The original objection letter of from in respect of application 20/03009/TREES to fell the sycamore tree in question, the tree to be felled for 25 years contains some detailed information and photographs on the tree itself.

In the first instance, it has to be reiterated that tree in question was in existence before planning permission was granted and the construction of 69 - 72 Riverside Gardens 75 - 78 Riverside Gardens took place. It is presumed that the appropriate design safeguards were taken to ensure that the tree roots to the sycamore never affected the aforementioned properties. In any event, local soils are not of a shrinkable clay type. In the original application form, it was stated that:

Given the distance the tree roots have travelled along water pipework there is now a strong possibility that the root will be growing under a neighbouring building.

No evidence such as an engineer's or building surveyor's report has been submitted in respect of this speculative assertion. Tree roots will grow far more easily along drainage runs. If tree roots are considered to be a potential hazard to a building, crown reduction or the installation can be effective preventative measures.

In the application form the following appeared:

Its growth over the last ten years has pulled up the public pavement. The pavement no longer meets legislative requirements for disabled people or for pushchales. With cars parking the other side of the road (and no pavement) it is causing people to walk in the road instead of on the pavement. It causes a significant trip hazard in the dark.

Whilst it is accepted that some limited unevenness has occurred on the pavement surface immediately adjacent to the tree, the photographs supplied by show the extent of unevenness, which would seem to decry the assertion that "the pavement no longer meets legislative requirements"

The damage to the water pipework concerns a surface water drain located on the private driveway serving Flats 6 9 - 72 Riverside Gardens, 73 & 74 Riverside Gardens and Kents Almshouses.

I raised concern regarding this surface water drain. The drain required unblocking. To the best of my knowledge this drain has never been cleaned since the construction of Nos 69 - 72 Riverside Gardens in the 1990's. The contractor employed to clean the drain discovered that tree roots, from the sycamore, had blocked the drain. The roots have been removed from the drain run the surface water drain which is now draining properly. Regular cleaning/maintenance of the surface water drain would have prevented the tree roots causing a problem.

The information supplied as part of the original application advises that the applicant is an absentee landowner whose apparent reason for continuing to own the land and tree on it was because it forms a ransom strip. A ransom strip might not be very effective with a tree on it. It is presumed that the applicant is a local property developer who has many and extensive land holdings in Hampshire and is a former Hampshire County Councillor. As a property developer and property owner, the applicant would be aware of the need to inspect and maintain trees on a regular basis. As a local resident and from the information supplied by others, it would appear that this tree has not benefitted from any crown reduction works or the provision of underground tree guards to drainage runs etc. Although a sycamore is not regarded as a tree of great merit in terms of species, this particular tree as stated by others is one of very few trees in the locality and is of attractive shape and form. Whilst it is fully accepted that as a species sycamore might not have a very long life expectancy and can produce many seeds in the autumn, which can give rise to considerable sapling generation. However its life should not be terminated by felling it completely because the current owner has failed to maintain it appropriately.

As a who has undertaken many on properties with trees within a zone of influence, I do not consider that this tree represents a danger to nearby properties. As it is apparent that the tree pre-dates the construction of the relatively new properties that adjoin it, it is presumed that the designs for the properties took account of the nearby tree, more especially as the ground conditions are not of shrinkable clay. I would therefore consider that with some crown reduction works and regular monitoring of its roots, there is no need to remove this tree in its entirety, more especially when it provides a haven for local wildlife and amenity for local residents.



In support of this, I make the following comments

No survey has been submitted to show that this tree is diseased and/or unsafe structurally. No evidence has been submitted to confirm the assertions that large branches have fallen and caused damage in recent times. As a resident of Riverside Gardens for over a years, I have never heard or seen evidence of any branches falling from it, whether causing damage or not.

This native mature tree is host to a wealth of wildlife and this supports the natural diversity of the environment here, supporting a wide range of insects, birds and foraging bats.

As the last remaining mature tree, which predates the development 69-72 Riverside Gardens, it enhances and softens the street scene in Riverside Gardens. It was protected whilst the flats were being built and should remain so . If drains were dug too close to the roots, and there appears to be no proof of damage from the tree roots, then the problem lies with the builder/developer rather than the tree.

Damage to the adjoining pavement is minimal - and at this point the pavement is wider than average. There are many places in Romsey where tree damage to the pavement is much greater and possibly inhibits passing with a mobility vehicle. That is not the case here
