# **REASON FOR URGENCY**

The councils IT infrastructure is heavily reliant on Microsoft software and technologies in order for the business to efficiently deliver services.

Currently there are two different types of licence agreements which are:

- Select
- Enterprise

Currently TVBC are registered as a 'Select' partner.

We have currently been subject to a licence audit by Microsoft in order to ensure that the Authority is compliant with appropriate licences in readiness for entering into a commercially beneficial Enterprise agreement in the next financial year.

Results of the audit have returned that the Authority is under licensed to a value of Approximately £35,000 due to projects that were delivered up to 3 years ago which did not procure the necessary licences at the time.

Microsoft agreed with the Head of IT that if the Authority enters into the Enterprise agreement this month (and not the next financial year as planned) then they will write off the £35,000 under licence cost.

Also the Authority will receive a further 20% CLG discount if the agreement is signed by the end of this calendar month.

Please note: The change from 'Select to Enterprise' is part of strategic planning 2009 – 2010 and with this approval is being brought forward into this financial year.

The cost of the Enterprise agreement is £45,250.00 per year over 3 x years (Includes CLG 20% discount).

(NB: If approval is not given then the Authority will have to pay the £35,000 under licence value in order to reach compliance at an extra cost to this financial year).
