Additionally, although they have a number of outbuildings, they are all used for various purposes throughout the school day. A site visit was carried out with the portacabin supplier, who have confirmed that one can be located at the open space, with access from King George Road. Another option could be to send electors to St Michael's & All Angels Parish Hall, which is an existing venue for other electors. However, this would be outside the polling district. There is also limited parking and the venue itself may not be of a suitable size if additional electors were allocated to it. Following the Member Panel meeting, the Brethrens Meeting Room Chichester Close was approached as a possible venue, but this is also not available for use as a polling station.	With everything taken into account and in the absence of any suitable permanent building, a new polling station to be created in a portacabin at King George Road open space, which will be within the polling district.
