SECTION D – REASONS FOR THE DECISION

Following the decision of Cabinet on 28 October as part of the Council's Fees and Charges 2016/17, further information has come to light regarding additional car parking capacity in Andover Town Centre. This new information

As part of the Council's Fees and Charges 2016/17, which was agreed by Cabinet on 28 October 2015, it was resolved that the £2 supplement at Andover Leisure Centre was to be removed with effect from 1 April 2016. Since this decision was made, additional car parking capacity has been realised at West Street, Andover. This means that there is no longer justification to keep the surcharge in the Andover Leisure Centre Car Park.

Due to changes in car parking capacity adjacent to Andover Leisure Centre, failure to remove the £2 surcharge at this stage could result in over charging of some car park customers.
