This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

- (3) **Contracts** Any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the Parish/Town Council –

- (a) under which goods or services are to be provided or works are to be executed; and
- (b) which has not been fully discharged.

- (4) **Land** Any beneficial interest in land which is within the area of the Parish/Town Council.

(5) Licences Any licence (alone or jointly with others) to occupy land in the area of the Parish/Town Council for a month or longer.

(6) Corporate Tenancies Any tenancy where, to your knowledge –

- (i) the landlord is the Parish/Town Council; and
- (ii) the tenant is a body in which the relevant person has a beneficial interest.

(7) Securities Any beneficial interest in securities of a body where –

- (a) that body, to your knowledge, has a place of business of land in the area of the Parish/Town Council; and
- (b) either –
 - (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - (ii) if the share capital of that body is of more than one class, the total nominal value of the share of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.
